Response #1

The MHSA CHS Jail to Community Re-Entry program will expand existing Correctional Health services in the following notable ways:

- Implement risk-needs-responsivity assessments
- Establish re-entry groups that will identify possible barriers to successful re-entry
- Develop tailored discharge plans

This comprehensive approach to discharge planning allows for the identification of referrals that are tailored to best meet the unique needs of each individual. Such referrals will include assistance with medications and benefits, as well as a range of other behavioral health services aimed towards supporting the individual's recovery and community re-integration. This MHSA-funded program will then work in tandem with outpatient BHS programs in order to facilitate direct linkages to the services identified during individualized discharge planning.
