Getting to Know Your NOABDs

Termination

The Termination NOABD is issued once the client is already in treatment or receiving services, and we make a decision to end treatment, but the client does not agree with the decision. Here are two scenarios and their timelines for the Termination NOABD:

You are terminating a client after you begin providing treatment due to the client not meeting medical necessity, but the client does not agree with the decision. You must mail or hand deliver the notice to the client at least ten calendar days before the date of termination.

You cannot get a hold of a client because the client drops out of treatment, is missing, is admitted to an institution where he or she is ineligible for further services (such as incarceration or long term hospitalization), or is deceased. In these cases, you may close

the file on the same date of issuing the Termination NOABD. You may also close the file on the same date if the client's address is determined unknown based on returned mail with no forwarding address.

Here are some important reminders based on what we have received thus far:

- Be sure to use the NOABD template for the Mental Health Plan, NOT for DMC-ODS.
- Do not fax or email to AQIS the 3 attachments, ONLY the NOABD.
- Do initial by each of the 3 attachments on the second page of the NOABD. This confirms that the 3 attachments were also sent with the NOABD.
- Fax coversheet/email should contain the clinician's name and phone number, program/clinic, and supervisor's name.
