  - Outpatient 50% of clinics and surgery centers will participate in the two county wide drills; 50% of dialysis and surgery centers will test the Facility/MHOAC Situation Status form in both the May and November exercises
  - o SNF/LTC 50% of SNF/LTC will conduct an evacuation drill
  - Home Health/Hospice conduct a tabletop exercise specifically for home health and hospice providers
