



COVID, numbers are higher than a few weeks ago but curves do seem to be leveling off. Percent positivity is dropping, case rates are around 20. St. Joseph Health (St. Joseph's Hospital, St. Jude Medical Center (Not Present) and Mission Hospital - 70 COVID patients - Opening a new ICU division, requested CDPH staffing assistance. Requested 150 care givers, provided 20. Take about a week to process and a week for caregivers to be on service.  Mission Hospital - Covid Census as of 8/25/21 (down from the last few weeks): 35 (12 ICU)
