I. CALL TO ORDER

- The meeting was called to order by Irma Chavando at 10:30am

II. INTRODUCTIONS/ANNOUNCEMENTS

- Attendance Information obtained from Zoom participant report.

III. APPROVAL OF MINUTES

- The January 23, 2020 minutes were approved.

IV. EMS/HEM REPORT

- 55% of our population is vaccinated; 70% of adults; 80% 50 or older; 1.8 million people are fully vaccinated in Orange County.
- There is a surge in COVID+ cases and hospitalizations.
- The After Action Report workshop was on July 12th, and a follow up workshop will be held in a week and a half and participation from the group is encouraged.
- OC EMS Agency Operations Center is activated, supporting the logistics for the Mobile PODs.
- OCHCA- EMS has Binax Antigen Tests and Ambry Test Kits (PRC test) available for immediate distribution.
- We need to meet all goals related to the coalition; incorporate grant deliverables: HVA needs to be updated yearly; Surge plans; Burn Surge Annex; exercises/training; outreach; FY 2021-22 (July 1, 2021 - June 30, 2022), is the end of a 5yr. Cycle. We will plan for the next 5yrs.

V. OLD BUSINESS

- Advisory Group Goals and General HC Coalition goals. Review goals met due to COVID-19 response and set new goals. Each group will be giving a report out.
- ReddiNet for HCCOC non acute facilities was discussed in 2019. Non acute status is now live on ReddiNet effective July 20th. Non acute training will be in September. 9th and ongoing monthly trainings on August 10th.
