COVID-19 Response Request for Proposals July 2020

Objective

Orange County has received an unprecedented amount of one-time funding to address and prevent homelessness. The Orange County Continuum of Care (CoC) has been meeting with the Emergency Solutions Grant (ESG) administrative entities, including the County, to ensure alignment and partnership in addressing homelessness.

RECOMMENDED ELIGIBLE ACTIVITIES

- Homeless Prevention for households who are at greatest risk of becoming homeless.
- Rapid Re-Housing services and financial assistance to resolve homelessness for persons currently experiencing homelessness.
- Innovative Responses specifically related to COVID-19 for those experiencing or at risk of homelessness.

With the funding available, we estimate to be able to:

- 1. Provide Rapid Re-Housing services to 1,000 households
- 2. Provide Homeless Prevention/Diversion services to 1,300 households
- 3. Identify if there are innovative approaches that can be used to streamline, enhance or provide different service types to address the impact of COVID-19 on homelessness

Funding Summary

Estimated Funding Available: over \$16 million

- State ESG-CV Round 1: \$2,267,738
- Federal ESG-CV Round 2: \$4,630,617
- State ESG Disaster Funds: \$219,124
- State ESG-CV Round 2: To be Determined (\$20 million Requested)
- Homeless Housing Assistance and Prevention (HHAP): Up to \$6,578,949 • Available funding will be based upon remaining funds after the Capital RFP awards

- OCHCA or CoC may chose to add any additional funding that comes in

Contract Term

- 12/1/2020 6/30/2022 (Subject to change)
- Single year contracts that are renewable annually based upon funding availability and satisfactory performance.
- · First year contract may be prorated in comparison to the second year

Note: California Emergency Solutions Housing (CESH) removed from available funding

Funding Source Details


- The funding sources in this RFP are one-time funds that are meant to provide direct services and financial assistance for people experiencing or at risk of homelessness.
- ESG and CESH funding can be used for the following services:
 - Diversion / Rapid Resolution
 - Homeless Prevention
 - Street Outreach
 - Emergency Shelter (including isolation shelter)
 - Rapid Re-Housing
- HHAP is the most flexible resource that allows for innovation and capital infrastructure

Eligible Applicants for RFP

This funding opportunity is open to Nonprofit Organizations that meet all requirements needed in order to be able to execute a contract with the County of Orange.

Programs that propose to serve Individuals, Transitional Age Youth (TAY), Persons Fleeing Domestic Violence. Note: Family funding will go through the Family Solutions Collaborative

The majority of funding requires the proposers meet additional requirements set for receiving HUD ESG funds.





Innovative Services

Innovative services are intentionally undefined.

Proposals will be reviewed in having impact for reducing homelessness in a quick and effective timeframe. Proposals do not have to demonstrate direct correlation to COVID-19, as all persons experiencing homelessness are at increased risk.

The RFP will reflect that proposals are contingent upon the availability of funding, which may limit willingness to submit proposals in this are.

ESG-CV Funding Plan

The Office of Care Coordination will be working with the Family Solutions Collaborative to provide 25% of the ESG-CV funding to serve families.

Funding Distribution

Funding will be distributed regionally based upon the 2019 PIT numbers with Anaheim, Garden Grove, Irvine and Santa Ana counts removed.

Note: HHAP and CESH Funding Plan to be determined at the direction of CoC Board and based upon proposals received.

ESG: Discussed Items

- Ad Hoc considered the split of funding, Rapid Re-Housing (70%) versus Homeless Prevention/Diversion (30%).
 - Ad Hoc was in agreement with this being a good target split in prioritizing homelessness, while having some funding to prevent those at greatest risk.
 - RFP will reflect that this is the intent but may be adjusted based upon received proposals.
 - Contracts will be set in a way that adjustments to the split can be made based upon observed need over time.
- Ad Hoc considered proposed distribution by Service Planning Area.
 - There was no concern regarding the proposed distribution of funds.

HHAP: Discussed Items

- Ad Hoc considered HHAP funding availability within this RFP.
 - Ad Hoc recommended that HHAP funding be included in the RFP and that language in the RFP should state that available HHAP funding would be determined based upon all remaining funds after the Capital RFP awards are made.
- Ad Hoc had limited conversation around HHAP Round 2 funding.
 - There was no definitive direction in this area. Language within the RFP will reflect that the County and CoC may chose to add additional available funding sources to the RFP for award.
 - Decision could be made a later time whether or not to include HHAP Round 2 funding.

CESH : Discussed Items



- Based upon projected available funding, the limited funds in CESH and the long period for spending down CESH, it was recommended that the CoC reserve CESH funding and not include at this time.
- CESH uses ESG regulations and could be added or awarded through this RFP at a later time if the CoC Board saw that need.
- Ad Hoc group engaged in conversation of whether to consider extending existing CESH and HEAP contracts for a third year.
 - Funding to extend a third year would be \$1,885,615.
 - Ad Hoc members spoke to the important of refunding programs that have demonstrated concept versus looking for the next thing. Discussed innovation within existing projects.
 - Ad Hoc expressed a need for clear agreed upon assessment of existing program performance and how it would be determined what would be eligible for additional funding.
