# CoC Board Nomination Overview

- The Office of Care Coordination on behalf of the Orange County Continuum of Care (CoC) has been facilitating the CoC Board Seat Nomination and Selection process.
- The Orange County CoC Board is charged with responsibilities and authorities on behalf of the General Members of the Orange County CoC.
- The Orange County CoC is comprised of a governing board that represents the stakeholder groups as detailed in the HEARTH Act.
- The Orange County CoC Governance Charter identifies that each CoC General Member (one representative from each agency or individual) will be allowed one-vote for each of the CoC Board seats to be filled during this election.

# CoC Board Seats Available

- The CoC Board looks to provide a well balanced perspective from multiple sectors to best lead the response to homelessness in Orange County.
- Some board seats require a certain background as set forth by HUD and the Orange County CoC Governance Charter.
- The following eight (8) seats are up for election:
  - One (1) seat for Public Housing Agency Representative
  - One (1) seat for Persons experiencing homelessness or formerly homeless
  - One (1) seat for Domestic Violence Representative
  - Five (5) At Large Seats

# At Large CoC Board Seat Priorities

- In order to ensure a well-balanced perspective from multiple sectors to best lead the response to homelessness in Orange County, the Orange County CoC took action to prioritize the following areas of expertise/experience for the five (5) At Large Seats:
  - One (1) seat for Behavioral Health background and expertise
  - One (1) seat for Faith Based Representation
  - One (1) seat for Health Care background and expertise
  - Two (2) seats for Expertise on homeless services / representation of homeless service providers

9/17/2020	Homeless Provider Forum for review of voting process. Nominees given opportunity for 5 minute presentations
9/18/2020	General member agencies with CoC voting rights are convened on a webinar for review of voting process
10/9/2020	Voting will close
10/28/2020	Nominees with the most votes will be presented to the CoC Board for ratification
11/18/2020	First CoC Board meeting for any new members
