VI. OLD BUSINESS

A. Ground Ambulance Service Basic Life support (BLS Rates Adjustment and Advanced Life Support (ALS) Rate.

On September 11, 2007 the Board of Supervisors OCEMS approved a new methodology for the adjustment of Basic Life Support ground ambulance rates and the Orange County Fire Authority's Advanced Life Support Paramedic Assessment and Transport fee. The method finds the percentage change in the annual "all Items" Consumer Price Index for the Los Angeles-Riverside-Orange County area. This percentage change is multiplied by a factor of 150%. OCEMS then utilizes the data from the U.S. Department of Labor Bureau of Labor Statistics to determine the change from the prior year and

calculate any proposed rate increases. In accordance with Orange County Emergency Medical Services Policy 720.00, Section 314, *Orange County Ambulance Rules and Regulations Related to Ground Service Rates Adjustment*, the City Managers and Fire Chiefs (of cities that adopted the Orange County Ambulance Ordinance) would be notified of the proposed basic life support (BLS) rates and invited to provide written or verbal comments and then the rates are brought to EMCC for consideration. For the last two years the proposed rates have not been sent to the Board of Supervisors for approval due to the economic conditions.
