The Orange County Request for Proposals (RFP) for 9-1-1 Emergency Ambulance Transportation Services #OC2014-01 has begun the final segment of the competitive process, which includes the protest period and scheduling the RFP for Board consideration and action.

Yesterday, Health Care Agency (HCA) Contracts Division released the “Notice of Intent to Award” and “Notice of Non-Selection” letters to the respective bidders. The results of the evaluation panels are summarized in the table below.

The proposed contract award is tentatively scheduled for consideration by the Board of Supervisors on March 24, 2015. The award of the contract is subject to protest and proposers have 5 business days from the issuance of the notices to submit a protest which is no later than the close of business on March 12, 2015 5:00 P.M.
