# Behavioral Health Services (BHS) Director's Report - Mary Hale

Mary updated the board on BHS county and contract services. In Adult and Older Adult Behavioral Health (AOABH), Emergency Treatment Services (ETS) the department is moving forward with new renovations. Six (6) recliners have been added in the seating area to begin the transformation of the physical facility and drawings were submitted to the architect for review. Also, in our Peer Mentoring Program, we are in negotiations with a new provider. This will include the triage grant which will focus on ETS and Emergency Room Discharges. In our Assisted Outpatient Treatment (AOT) Program, we currently have six (6) settlement agreements. We have received a total of 338 referrals with 79 of those referrals accepting voluntary services. In our South County clinic, services have moved from Mission Viejo to Aliso Viejo (5 Mareblu) which will now be collated with our substance use clinic. The Recovery Center and Program for Assertive Community Treatment (PACT) will be located in Mission Viejo. Finally, in regards to our North Recovery Access, as of July 1, 2015, our county Recovery Center will be transitioning to become an Open Access location for open clients within Behavioral Health Services to include hospital and jail discharges. We will begin the phase slowly as we continue to notify our constituent facilities.

## **BHS Report Continued**

- In our Children, Youth and Prevention Behavioral Health, Innovations Programs, the Board of Supervisors approved two (2) programs, "Behavioral Health Services for Military Families" and "Religious Leaders Behavioral Health Training." These services are scheduled to begin on July 1, 2015.
- Furthermore, in Prevention and Intervention, the Community Counseling and Support Services Program began in June, which is funded with Prevention and Early Intervention (PEI) funds. Flyers will be shared with the board to include contact information about this program. Also, the Memorandum of Understanding (MOU) was approved by the Board of Supervisors for the School Based Mental Health Services. This program will provide a combination of prevention and intervention services, initially to students 11-13 years of age who with present with, or are at risk for, mild to moderate mental health symptoms.
- Moreover in our Mental Health Services Act (MHSA) Administration unit, the Mental Health Services Oversight and Accountability Commission (MHSOAC) have released two sets of proposed regulations with a potential effective date of October, 2015. Also, the MHSA Plan Update was approved by the Board of Supervisors on June 2, 2015. Finally, in our Community Supports and Services (CSS) component, there are available funds that can be used for program expansion and program development. A community planning process has been developed that will include input from important stakeholders, including the MHB, to identify gaps and needs in our CSS system of care.
