Open MHSA Public Hearing

- Opening Remarks and Housing Overview: Dr. Sharon Ishikawa, MHSA Coordinator
 - O Dr. Ishikawa thanked the guests in attendance and the members of the Mental Health Board. She explained the purpose of the Public Hearing and provided an overview of the Housing amendment to the Mental Health Services Act (MHSA) Three- Year Program and Expenditure Plan for Fiscal Year (FY) 17/18-19/20. She informed the MHB that this amendment was established through a Board of Supervisor's (BOS) directive on March 19, 2018, to transfer \$15 million in Community Services and Support (CSS) funds to CSS Housing Program. She answered several questions from the Mental Health Board, and then provided a written summary and reviewed all public comments received during the 30-day public comment period for the plan. There were a total of four written public comments received.
- Public Comment:
 - There was a total of one (1) public comment, the individual shared of his
 concerns with regard to low oversight on the MHSA plan and concerned with
 the length of time it will take to allocate the funds and provide the services.

Close Public Hearing and MHB Agreement:

• Chair Michaell Rose clarified that a vote was not necessary to move the amendment forward, rather an agreement and support from the MHB members who were present. Four members were in support of the MHSA Plan amendment, with 1 member who abstained.

Committee Reports:

- Older Adult (OA) Ad Hoc Committee- Karyl informed the board that they are working on a letter of support for services for the OA population. They will finalize the letter at their upcoming meeting next week.
- CAAC & CQIC: Joy reported that at the last CAAC meeting there was conversation
 to split up CAAC into the CQIC and MHSA Steering Committee, however the
 members were not in support of this idea and CAAC will continue to be a standing
 committee.

Old Business:

- Dr. Rose passed around a sample of the final MHB Annual Report which is currently being printing in Publishing Services.
- Dr. Rose reminded the members of the AB1234 Training and of the upcoming site visits.
