MINUTES

I. CALL TO ORDER

- The meeting was called to order by Kim Zaky at 10:30 a.m.

III. APPROVAL OF MINUTES

- September 18, 2019 meeting minutes were approved

IV. EMS/HEM REPORT

- **AlertOC** – Residents are encouraged to sign up for AlertOC.
- **Upcoming exercises** – The OA Countywide Functional Exercise will take place January 30, 2020 and the OA Jurisdictional Exercise will occur on March 31, 2020
- **MRC** – MRC is currently on hold.
- **Recruitment** – Program is currently recruiting for three vacant positions, two program supervisors and a nurse.

V. OLD BUSINESS

- **Table top** – Chris Riccardi conducted a follow-up discussion on the table top exercise that occurred at the September 18, 2019 meeting.
- **Goals**
 - i. **Membership** – increase participation has been met and will be removed from further agendas
 - ii. **Ambulance strike teams** – Program will work with Rob Viera to schedule Ambulance Strike Team Training.

VI. NEW BUSINESS

- **Group representation** – Overview on purpose of the HCCOC and planning for emergency preparedness. Program will send a survey in Jan. 2020 to reformulate our goals and ask for ideas on what this group wants to work on. One or two point persons for Fire, Ambulance, ERCs, Base Hospitals, Traumas and EMS that will share information, will be identified.
- **Communication plan** – A Communication Tree for the entire HCCOC is in process.
- **Sit Reps** – The Facility/MHOAC Sit Rep was used during Statewide for SNF/LTC; HHH; Outpatient dialysis; clinics and surgery centers. Ongoing training will occur for these groups.

- **ReddiNet** – Beginning in 2020, healthcare facilities wanting to be members of the HCCOC will be required to have ReddiNet. Trainings will be provided.
- **Advisory committee reports** – Report out from each of the Advisory groups at the big coalition meeting
 - **Hospital** – 30% of the hospitals have attended at least 80% of the time
 - **EMS** – CHOC conducted a pediatric surge table top to identify gaps within the County
 - **Outpatient** – 50% of clinics and surgery centers will participate in the two county wide drills; 50% of dialysis and surgery centers will test the Facility/MHOAC Situation Status form in both the May and November exercises
 - **SNF/LTC** – 50% of SNF/LTC will conduct an evacuation drill
 - **Home Health/Hospice** – conduct a tabletop exercise specifically for home health and hospice providers
- **MCI**s – A presentation on Field MCIs occurred.
- **Fountain Valley Hospital 15 to 50** – Fountain Valley Hospital presented on the 15 to 50 exercise conducted at their facility.
