



COMPLIANCE WITH SENATE BILL 1383

Food Donations and Economic Solutions for Retail Food Establishments

WHAT IS SB1383?





SB 1383 is a statewide effort to reduce emissions of short-lived climate pollutants by reducing organic waste disposal to 50% by 2020 and 75% by 2025.



To reduce food waste and help address food insecurity, SB 1383 requires that by 2025 California will recover 20% of edible food that would otherwise be sent to landfills, to feed people in need.



Starting January 1, 2024, regulations may require local jurisdictions to impose penalties for noncompliance.



THE CONCERN

- Californians sends 11.2 billion pounds of food to landfills each year, some of which were still fresh enough to have been recovered to feed people in need.
- In California, 4,104,060 people are facing hunger
- One in seven children are food insecure







BENEFITS





Conserves Landfill Space

About 30% of material sent to landfills is food waste.



Reduces Methane

Decomposing food waste in landfills emits methane, a gas that traps the sun's heat, contributes to climate change and is 84 times more potent than carbon dioxide

Feeds People

Donated food helps feed people that are in need or are food insecure



Covered by the Good Samaritan Act

Protects businesses from liability when donating to a food recovery organization



Non-perishable items that we throw away. Instead of throwing it away, we will donate it. This includes, but is not limited to:


- Canned items
- Cereal
- Rice
- Beans

- Condiments
- Pasta
- Cookies and crackers
- Juices
- Dry goods

We will also donate non-taxable items. Such as:

- Toothpaste
- Toilet paper
- Detergent
- Mouthwash

- Hand soap
- Shampoo
- Paper plates

Perishable is not donated, but it does not get thrown away.





Donations are processed by the Receiver Scanned and weighed



A donation report is received daily to review scanned donations



Food bank picks up once a week




Food banks distribute donated food to families that are food insecure

INSPECTION

A waste inspector will visit the store, at least once a year, to ensure we are following the program. They will be asking for the following items:





- Donation tracking log This should be inside the binder, on the Receiver's desk.
- ✓ Vendor Agreement This should be inside the binder, on the Receiver's desk.
- Pickup schedule with Agency contact information This should be inside the binder, on the Receiver's desk.
