

# **Overview of Outpatient Services**


- Serve youth ages 0-21 years old


# Number of Youth Served in CYS Outpatient Clinics by Fiscal Year




# Number of Children and Youth Served and Services in Fiscal Year 2022-23



# **Evidenced Based Therapies**

# Trauma-Focused Cognitive Behavioral Therapy (TF-CBT)

A structured, short-term treatment model used with children and adolescents ages 3 to 18 and their parents or caregivers that effectively improves a range of traumarelated outcomes.

# **Eye Movement Desensitization Reprocessing (EMDR)**

A structured therapy using lateral eye movements and/or other stimuli such as hand-tapping and audio stimulation to alleviate the distress associated with traumatic memories.

# **Seeking Safety**

A present-focused therapy that helps clients attain safety from trauma and substance abuse by emphasizing coping skills, grounding techniques, and education.

# **Motivational Interviewing**

A collaborative, goal-oriented approach designed to strengthen personal motivation for and commitment to a specific goal by eliciting and exploring the person's own reasons for change.

# Cognitive Behavioral Therapy (CBT)

Aims to help clients identify and explore the ways their emotions and thoughts can affect their actions in order to help them learn how to change behaviors and develop new coping strategies.

# Dialectical Behavioral Therapy (DBT)

Aims to help clients develop skills to regulate intense emotions, reduce conflict with others, manage stressful thoughts, identify healthy coping strategies, and make meaningful connections with others.


# Children and Youth Experiencing Reduction in Clinical Distress FY 2022-23




# Numbers of Children 0-5 years and Services in Fiscal Year 2022-23




# total children 0-5 years served in CYS

# **Evidenced Based Therapies for Children 0 Through 5 Years of Age**

# Parent-Child Interaction Therapy (PCIT)

Focuses on promoting positive parent-child relationships and interactions and teaching parents effective child management skills. Intended for families with children 2-6 years old who are experiencing emotional and behavioral problems that are frequent and intense.

# Positive Parenting Program (Triple P)

Offers practical strategies to help parents better understand and support their children's emotional and developmental needs by building strong and healthy relationships and improving communication.

# Parent-Child CARE (PC CARE)

Targets improving caregiver-child relationships and supporting parents/caregivers in the development of new child behavior management strategies. A brief intervention for families with children 1-6 years old who may have experienced a traumatic event, may be adjusting to a new home, or may be exhibiting disruptive or defiant behaviors.



# **PCIT Success Story #1**

A young boy with behavior problems was referred to an outpatient clinic. He would have emotional outbursts, be physically aggressive, yell, touch others inappropriately, and refuse to follow rules. The therapist helped the family by using PCIT (Parent-Child Interaction Therapy) skills. For the first 6 weeks, they focused on Child-Directed Interaction (CDI) to improve the bond between the mother and the child.

Once the mother got good at CDI skills, they moved on to Parent-Directed Interaction (PDI) skills. This part focused on getting the child to follow rules and show positive behaviors. The mother noticed big changes: the inappropriate touching stopped, and the other behavior problems got much better.

By the end of PCIT, the mother saw a big improvement in the child's behavior at home and school. The child paid more attention at school and followed rules better at home. The mother also felt her relationship with the child had improved. A month before finishing PCIT, the child even received a citizenship award at school for good behavior.

# **PCIT Success Story #2**

A young boy was getting help because he had symptoms of inattention, difficulty following rules and frequent tantrums.

When they started PCIT, the mom was both excited and nervous. The boy did well during PCIT sessions and his inattention quickly improved. He still had trouble with anger and following rules. The mom found it hard to attend all the sessions but kept practicing at home using the skills she learned.

Over time, as the mom changed how she gave instructions and interacted with her son, his behavior improved. He started to communicate better with his mom and even used some of the skills he learned in PCIT. After about 10 months, the boy's behavior got a lot better, and his mom's stress levels dropped. She noticed fewer tantrums and better behavior from her son.

By the end of the program, the mom realized how helpful PCIT was. She continued using the skills and enjoyed the daily routine with her son.

# **Overview of FSPs and PACT**

- "Whatever it Takes" model of treatment
- Evidence-based and strengths-based model
- Emphasis on field-based services servicing all of Orange County
- Intensive, mental health care coordination services that will address family needs across all life domains of the client
- 24/7 access to services
- Services are voluntary
- Youth must reside in Orange County

# Who is eligible for an FSP program?

CYS Full-Service Partnership (FSP) programs serve children and Transitional Age Youth (TAY) who have a Serious Emotional Disorder (SED) or Severe Mental Illness (SMI) and are in one or more of the following target groups:

- Homeless or at risk of homelessness
- Unserved or underserved because of linguistic or cultural isolation
- With a history of multiple psychiatric hospitalizations
- Experiencing their first psychotic episode
- Exiting the Social Service or Probation Systems
- With special needs and/or co-occurring disorders
- Children of parent(s)/guardian(s) with serious mental illness, or
- Ages zero (0) through five (5) and school age children who are unable to function in the mainstream school, preschool or day care setting because of emotional problems.

# **Roles of FSP Staff**

**Personal Service Coordinator (PSC):** The Bachelor's level PSC is the point of contact for the client and family and works with the client to build their independent life skills, work on external behaviors that are causing barriers to their functioning, assist in facilitating of groups, link members to the community and outside resources, and facilitate continuity of care.

**Lead Personal Service Coordinator (Lead PSC):** The Master's Level Lead PSC supervises a team of PSC's, conducts therapy with a small caseload, completes assessments, facilitates groups and assists with the handling of crises throughout the day.

Clinician: Conducts group and individual therapy, completes assessments and provides crisis intervention.

Clinical Supervisor: Supervises the therapists, assists in training of staff.

**SUD Counselor:** Assists members with becoming and remaining sober by educating them on patterns of substance use/abuse to increase insight, facilitates groups.

# **Roles of FSP Staff (Continued)**

**Housing Coordinator:** Assists members (and families if applicable) with housing needs, maintains relationships with housing vendors, handles housing crises as needed, and facilitates groups related to housing issues.

**Education Coordinator:** Assists members with all educational goals including, but not limited to, applying for school, arranging for high school completion or GED, touring schools, applying for financial assistance, obtaining school supplies, and helping members become successful in their education.

**Employment Coordinator:** Assists members (and families) with all employment goals including resume building, mock interviews and applying for jobs.

**Parent and Youth Partners:** Teams with either the parent or youth to work on parenting/skill building, coaching and community integration/linkage. Monolingual parenting groups are facilitated by parent partners.

# **Project FOCUS**

**Population Served:** Culturally- and/or linguistically-isolated Asian/Pacific Islander (API) children, adolescents, and transitional age youth, ages 0 up to 26, who are living with a severe emotional disturbance and/or serious mental illness.


