Behavioral Health Re-Entry Services: Jail to Community Re-Entry Program (JCRP)

Christina Weckerly and her team provided a comprehensive overview of the Jail to Community Re-Entry Program (JCRP). JCRP is embedded in jail services and services end once person is discharged. In program for ~90 days. Their team provided information on how JCRP System was part of correctional health services to behavioral health services to help individuals with discharge plans better and facilitate linkage into systems of care. The team provided information on times of availability, locations of programs, and how they serve the population by building rapport with clients, assessing needs to coordinate care and provide warm handoffs. JCRP collaborates with Sheriff's Team shared a success story from the program. BHAB Board requested quantitative information regarding JCRP program.
