# **Medi-Cal Older Adult Expansion**

On July 28, 2021, Governor Newsom signed Assembly Bill (AB) 133 into law, which removed immigration status as a barrier to full-scope Medi-Cal eligibility for California residents ages 50 and over. This expansion helps to make California's health system more equitable and universal for everyone.

#### What is the Medi-Cal Older Adult Expansion?

As of May 1, 2022, a new law was passed that allows all eligible California residents who are 50 years old or older to receive free full-scope Medi-Cal. Under this expansion, **immigration status is not taken into account** and eligible individuals can qualify for Medi-Cal even if they are undocumented.


#### What benefits does full-scope Medi-Cal include?

Full-scope Medi-Cal benefits include:

- Primary
- Specialty
- Behavioral health
- Long-term care
- In-home supportive services
- Home and community-based services
- Transportation
- Vision (eyeglasses)
- Hearing aid coverage

# Can enrolling in Medi-Cal hurt my client's immigration status?

No. Enrolling in Medi-Cal will not affect their current or future immigration status.



#### When can my newly eligible client enroll in Medi-Cal?

Applying for Medi-Cal can be done at any time of the year.

#### What is the eligibility criteria for Medi-Cal?

Medi-Cal eligibility is based mainly on an individual's income. Medi-Cal eligibility can be determined by viewing the Medi-Cal qualifying income information chart on the following webpage:

# **ENROLLING IN MEDI-CAL**

For Orange County residents, there are multiple ways to apply for Medi-Cal:

#### **Apply Online**



Covered California has a partnership with the California Department of Health Care Services.

Medi-Cal and Covered California use the same application. Clients can visit www.coveredca.com to apply online.
