### Role of the Advisory Board and Members: Susan Wilson

awareness of the future impacts of Prop 1. Chase suggested having the counties collaborate to have larger presence and impact on the community.

## BHS Vision & Update: Ian Kemmer

• Ian Kemmer provided a comprehensive overview of services provided by BHS programs over the calendar year 2024 and provided context for the approach of plans and goals for 2025. He highlighted numbers of the community served, calls into OC Links, and major accomplishments including the BHSA modernization, Opioid Abatement and Narcan Distribution in the community, CalAIM, CARE Act, Mobile Crisis Benefit, and monitoring and implementation of both SB 43 and Prop 36. Ian also provided updates regarding the status of Be Well for both the Orange and Irvine campus. During this update, Alan inquired about being involved in the contract selection process and procurement process, which can be addressed at a later meeting. Board members provided their feedback about working with contracts. BHS will continue to keep BHAB updated on the status of both Be Well campuses as public information is released. Looking ahead to 2025, Ian acknowledged the future challenges that BHS will face, primarily due to the change in funding and provided the plan for working through the challenges.
