<u>Description of Proposed Change(s)</u>: OC Waste & Recycling as the owner/operator of the Prima Deshecha Landfill has submitted a permit modification application package for Solid Waste Facility Permit (SWFP) based on the directives given to the operator as part of the Five-Year Permit Review Report. The proposed key modifications are as follows:

- 1) Include chipping and grinding activities and Self-Monitoring and Reporting requirements.
- 2) Update the facility's APN numbers in the SWFP.
- 3) Update the Alternative Compliance Plan (2018).

As part of the SWFP permit modification, the Report of Facility Information (RFI) prepared as a Joint Technical Document (JTD) was also amended to include information as it relates to current facility operations.

<u>LEA Determination</u>: The LEA has accepted the application after determining the proposed changes and updates do not conflict with the existing SWFP, meet applicable State Minimum Standards, and are consistent with all California Environmental Quality Act (CEQA) documents on file prepared for the facility.
