## 4. OCEMS REPORT

OCEMS Report

*Dr. Carl Schultz:* Triage to Alternate Destination for psych patients has been approved by the state. We now must arrange financing for the educator to certify the paramedics to Anaheim Fire, who volunteered to spearhead this project. Once everyone is trained, we will be ready to go and hopefully that will only be a couple more months. AB40 is the state's attempt to improve APOT with an audit tool. This is a work in

progress. EMSA is working with CHA, who will be working with local agencies to provide contact emails for the hospitals. There is a webinar on Thursday for provider agencies. Please review the EMSA website for more information.

Gagan Grewal, MD: EMSA released for comment the Chapter 6 regulations for specialty centers and specialty designations. Please review. Submissions for comments are due on August 17<sup>th</sup>. Go to EMSA's webpage for the submission instructions. ACEP will be having a webinar on July 17<sup>th</sup> for hospitals to prepare to be a pediatric receiving center from 8:30 to 9:15 a.m. The Behavioral Health Division with the Health Care Agency is currently working on rolling out SB43. They are going through HASC to contact hospitals within the area. They should be reaching out to you soon to coordinate what that will look like for you and what the requirements are. There will be a HICS training on August 7<sup>th</sup> here at the AOC from 8 a.m. to 12 p.m. There will be a two-day Health Disaster Management Training (HDMT) training on August 20<sup>th</sup> and 21<sup>st</sup>. Ambulance Patient Off-Load Time (APOT) and Diversion Report by Jason Azuma, NRP

APOT in April was good at 25 minutes. May was at 24. June was at 23, but it is not yet published. We had a little of a reprieve down in volume at 530-ish patients per day. Even though our system aggregate is below our benchmark of 30 minutes, the AB40 rules will impact any hospital that have runs that exceed that 30-minute standard. Based on the performance of your hospital you may still receive communications from the state regarding performance. For diversion we continue to run a little high for April and May, at or above our 6% threshold, which is roughly 1000 hours for the system. We are at about 900 hours for June.

## 7. <u>NEW BUSINESS</u>

UCI Medical Center Trauma Center and Pediatric Trauma Center Redesignation by Ruth Clark, RN

The adult trauma center received one non-compliance for the number of registry staff they have versus the number of trauma patients they receive. Their corrective action is due February 4<sup>th</sup>. The endorsement is three years conditional and would change to unconditional once the corrective action has been completed.

The pediatric trauma center received one non-compliance that requires a documented effectiveness of the PIPS program. Their corrective action is due February 4<sup>th</sup> with a required return site visit. The endorsement is one year conditional and to reassess after their repeated site visit.

Anaheim Global Medical Center ERC Designation by Genise Silva, RN

For their ERC, there were three deficiencies identified. APOT of more than 30 minutes, ReddiNet response rate for MCIs <90% compliance and noncompliance with OCEMS policy #300.00 regarding having an on-call pediatrician. The endorsement is for three years conditional.

St. Jude Medical Center ERC, BH, CBRC, and SNRC Designation by Genise Silva, RN

ERC – They had two deficiencies, APOT exceeding 30 minutes and <90% ReddiNet response rate. Endorsement is three years conditional. BH didn't have any deficiencies. The endorsement is three years unconditional. CVRC had one deficiency, non-compliance with OCEMS policy #630.00: lack of inclusion of Development of cardiovascular education and outreach program." The endorsement is three years conditional. The SNRC had no deficiencies, and the endorsement is three years unconditional.

Orange County Global Medical Center Trauma Center Redesignation by Ruth Clark, RN
 Back in November 2024 it was reported the adult trauma center had two non-compliant standards which have been resolved with ACS now verifying. The endorsement is for two years unconditional.

Motions approved to accept all recommendations listed above for these designations as stated. No opposition to the recommendations.

OCFA Utilizing cell phones for ALS no-contact by Stephanie King, RN

OCFA is going to be trialing for 90 days starting August 1<sup>st</sup> utilizing their company cell phones to make ALS no-contact. These will come into your red-phone, or your paramedic dedicated line.
