

FROM BEHAVIORAL HEALTH SERVICES DIRECTOR

he OC Health Care Agency's (HCA) Behavioral Health Services (BHS) is pleased to collaborate with the Behavioral Health Advisory Board (BHAB) in presenting the BHAB's Annual Report to the Orange County Board of Supervisors (BOS) and the diverse stakeholders of Orange County. As a department, our mission is to provide high-quality mental health and substance use prevention, treatment, and recovery support to the residents of Orange County, California.

The BHAB impacts communities by promoting awareness about mental health and substance use disorders, reducing stigma and discrimination related to behavioral health conditions, valuing diverse opinions, and encouraging and supporting the principles of recovery, wellness, and resiliency in the community.

BHS has worked with the BHAB throughout the past year to ensure greater understanding of the current system of care within the community, respond to feedback to improve programs and services, and work more collaboratively with stakeholders on future behavioral health endeavors.

I remain inspired by the BHAB's dedication,

volunteerism, and genuine concern for the community's behavioral health needs as well as their commitment to improving the behavioral health system of care. Their dedication is more important now than ever as we begin to shift the behavioral health system to meet the many State and Federal changes impacting the health care system. We have challenging times ahead, but working together will better enable us all to change the challenges into opportunities to better serve and support our diverse communities.

FROM BEHAVIORAL HEALTH ADVISORY BOARD CHAIR

he year 2024 marked a period of significant change for public behavioral health — not only in Orange County, but throughout California. With the narrow passage of Proposition 1 in March (approved by voters by just 50.2% to 49.8%), a major shift began in how funding for mental health care, substance use treatment, and homelessness services may be utilized.

BHAB has closely monitored how funding for existing services will be impacted and how new programs will be planned and implemented in accordance with Proposition 1 (for more information go to: https:// www.calbhbc.org/bhsa.html). Of particular concern is the impact on local prevention programs and services, which will now fall under the responsibility of the California Department of Public Health. (for more information go to: https://www.calbhbc.org/ bhsa.html). Other issues that the BHAB has monitored over the past year include the implementation of Proposition 36 (2024), which established a new treatment-focused court process for certain drug possession offenses. For example, it allows people convicted of possession of illegal drugs (specifically, those who possess drugs such

as methamphetamines or fentanyl or those who have two or more past convictions for drug crimes) to be charged with a "treatment-mandated felony" instead of a misdemeanor in some cases. Upon completion of treatment, charges can be dismissed.

Also on the watch list is the implementation of SB 43 (2023), which expanded the definition of "gravely disabled" to include individuals who, because of severe substance use disorder, or a co-occurring mental health disorder and a severe substance use disorder may now be considered "gravely disabled". The bill also expanded the definition of "gravely disabled," to include the inability of a person to provide for their personal safety or necessary medical care as a result of chronic alcoholism. The BHAB will continue to monitor these items in 2025.

Lastly, we experienced the loss of an integral member of our board this past year. Karyl Dupee, who had served on our BHAB since December 2016, passed away in November 2024. Karyl was a fierce advocate for the older adult population in Orange County and a generous contributor to the many other issues this board has addressed over the years. Karyl's advocacy in support of developing a system of care for older adults living

with both behavioral health and physical/neurocognitive conditions came to fruition in November 2024, when the Mental Health Services Act (Prop 63) Oversight and **Accountability Commission** approved Orange County's Older Adults Innovations Project. This project, which Karyl inspired and championed, will focus on this critical issue.

ABOUT THE BEHAVIORAL HEALTH ADVISORY BOARD

he Annual Report of the Behavioral Health Advisory Board is submitted in accordance with the California Welfare and Institutions Code (WIC) 5604.2(a). Under state law the BHAB is required to review and evaluate the behavioral health needs, services, and special projects in the Orange County community. The BHAB's requirements also include advising the BOS and BHS Director as to any aspect of the local behavioral health programs.

The BHAB is comprised of 14 volunteer members, plus one member of the BOS. Each supervisor makes an individual appointment, and the BHAB Nominating Committee also recommends the appointments of new members. The categories of membership include:

- Member of the BOS
- Consumer
- Family Member
- Mental Health Professional
- **Public Interest**

The BHAB serves as a link between the BOS and BHS by enhancing public input into the delivery of community behavioral health care services. The BHAB met regularly, holding two meetings each month: a Study Committee meeting and a General Meeting. These meetings are open to the public and public comment is encouraged to voice community input on all aspects of behavioral health services.

Activity around the following specific issues by the Older Adult Services Committee occurred in 2024 and incorporated both participant dialogue, community input; information requested by the committee from, and presentations provided by various BHS staff:

- A recommendation that the County initiate an annual report called "Behavioral Health Conditions of Older Adults in Orange County," provided specifically to older adults (age 65+) in Orange using multiple indicators of the behavioral health of the County's older adult population (submitted)
- A recommendation that in-person training and informational presentations by the OC HCA be made available on a regular basis to various community groups to ensure that they remain familiar with the crisis services that are available to

- the public, how to access those services, and what to expect when crisis services are requested (submitted)
- Another recommendation from this committee included the Mental Health Services Act (MHSA) Innovation (INN) P.I.V.O.T. project, which offered funding for such a program for older adults with co-occurring neurocognitive disorders and mental health conditions. With the Oversight and Accountability Commission's (OAC) recent approval of this project, the OAC expects to expand its support into the implementation phase. The OAC will also continue to monitor how Prop 1 will impact mental health services for the Older Adult community (completed)

ADVISORIES TO THE BOARD OF SUPERVISORS AND BEHAVIORAL HEALTH DIRECTOR IN 2024

The following formal communication and advisories were submitted to the Orange County BOS and BHS Director in 2024:

Meeting the Needs of Older Adults in Orange County

The BHAB applauded the OC HCA's (HCA) successful submission of an Older Adults Innovations Project which was proposed by the BHAB's Older Adult Services Committee (chaired by Karyl Dupee, LMFT). This proposal was approved by the Mental Health Services Act (Prop 63) Oversight and Accountability Commission on November 21, 2024.

The intent of this project moving forward is to develop a system of care for older adults living with both behavioral health and physical/neurocognitive conditions, which may include individuals who are homeless or at risk of homelessness. Currently, this combination of services to specifically address the complex needs of this special population in Orange County are not in place.



Data and Reporting Improvements

The BHAB voiced strong support of the intent of the HCA to begin tracking behavioral health data associated with the older adult population separately from the general adult age group in order to more closely monitor the needs of this particular segment of our community and the services being provided.

Data and Reporting Needs

The BHAB recommended that the HCA create an annual report to the community that provides information on the behavioral health services provided specifically to older adults, age 65+, in Orange County using indicators that include the following:

- Number served by BHS annually
- Number served by BHS, by race/ethnicity
- Number of services provided by type of outpatient program
- Number of Bed Days, by Type of Inpatient Placements

- Rate of Orange County Hospitalizations for Mental Illness and Substance Abuse by City of Residence
- Mental Health Hospitalization Rates by Diagnosis and Race/Ethnicity
- Rate of deaths due to suicide

This data can serve as a useful tool for current and future program planning aimed at addressing gaps in services and monitoring trends in the behavioral health conditions impacting the aging population in Orange County.

Targeted Community Education & Outreach

The BHAB heard from several community groups (e.g., faith-based organizations, public service and other community resource entities) in Orange County who frequently encounter individuals who appear to be in need behavioral health and/or crisis intervention services. Unfortunately, these groups report that they are often unaware of how to obtain immediate assistance in dealing with

these individuals who might benefit from County behavioral health services.

In-person training and informational presentations by the OC HCA should be made available on a regular basis to ensure that concerned community groups remain familiar with the crisis services that are available to the public, how to access those services, and what to expect when services are requested.
